Annual Meeting 2025

ELECTION GUIDELINES AND NOMINATIONS BY PETITION

The 2025 Annual Election for the Board of Directors will be posted along with Committee nominees in each Credit Union office by January 31, 2025.

Nominations by petition must be filed with the Secretary of the Board no later than 4 p.m. on December 16, 2024.

If there is at least one nominee for one vacant Board position at the time of the Annual Meeting, nominations will not be allowed from the floor. In the event there is only one candidate for a position, the Chair may take a voice vote, or declare each nominee elected by general consent. Otherwise, ballots will be distributed, marked, collected and tabulated, and the results will be announced at the Annual Meeting. No mail ballots, absentee ballots or proxies will be allowed. Elections will be determined by plurality vote.

Nominations By Petition

If you would like to submit your name or the name of another member as a candidate for one of the open positions, please call Jerry Macomber at 571-250-2019.

The following information pertains to nomination by petition:

- Any Strategic Federal Credit Union member at least 18 years of age is eligible to hold elective office.
- Nominations for any vacancy may be made by petition signed by at least 21 members of voting age.
- Nominees must provide a certificate stating that he or she is agreeable to nomination and will serve if elected to office. A brief statement of qualifications and biographical data in the form specified shall accompany each nomination by petition.
